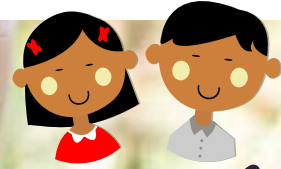

# Thailand

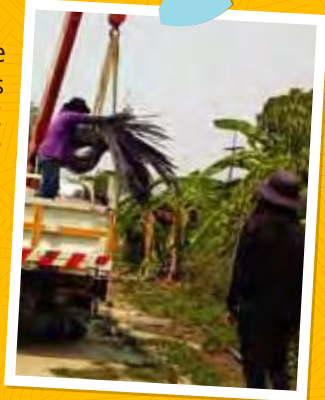
